Description			
Provide a short description of the event and its activities.			
On 18 March 2025, the Blue4EU project organized a youth reflection workshop in Rome, Italy, under the work package “Learning from the Past for a European Future” (WP8). The event gathered 25 young			

participants, experts and stakeholders to reflect on oral history stories they had previously collected and to explore their relevance in the context of European Union Fundamental Rights.

The workshop began with a welcome session and an introduction of participants and facilitators. This was followed by a structured “show and tell” activity, during which participants presented their collected stories in various formats such as drawings, readings, videos, or animations. The session emphasized individual and group reflection on key insights from these narratives.

A subsequent session introduced the EU Fundamental Rights framework. Participants then worked in small groups to cluster their stories into thematic “Blue4EU Story Puzzles,” illustrating how personal testimonies can support, promote, and connect with fundamental rights. The discussions also focused on tailoring these story clusters to different community audiences, including youth, educators, cultural facilitators, and older generations.

In the afternoon, participants reflected on the life lessons they had learned through their oral history work and their interactions with interviewees. These lessons were clustered collaboratively and served as a basis for brainstorming dissemination strategies aimed at other young people, with the goal of sharing personal insights and reinforcing awareness regarding EU values and rights.

The workshop concluded with a structured reflection and evaluation session, where participants completed dedicated feedback forms and shared closing thoughts on their experiences.

This activity, funded by the European Union, contributed to fostering civic awareness among young participants, encouraging intergenerational dialogue, and promoting engagement with Europe’s shared history as a foundation for a common future.

In total, the workshop engaged 25 young people, producing a valuable collection of reflection moments and 5 social media posts inspired by the participants’ learning.
